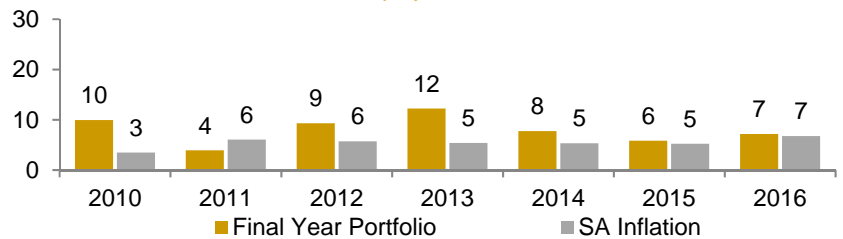

CALENDAR YEAR RETURNS (%)



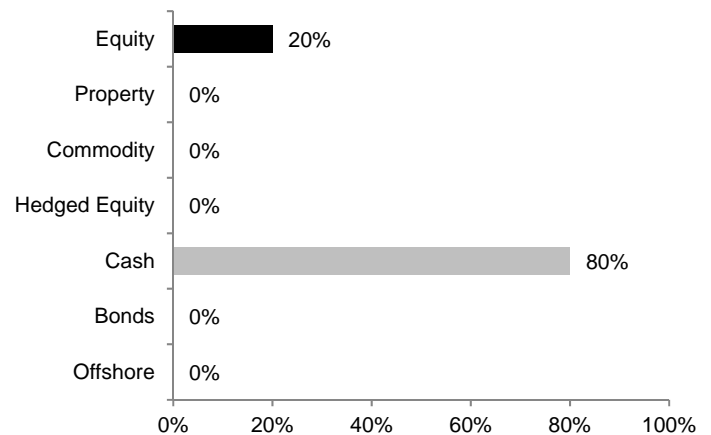
FUND OVERVIEW
