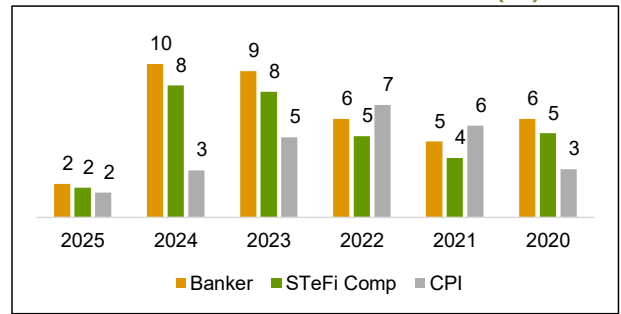
About the portfolio
