About the portfolio

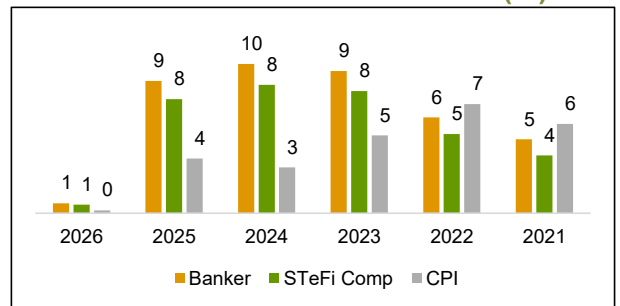
